Construction Products Europe hosted a workshop on sustainability assessments methodology which took place on 4th March. Construction Products Europe provided a comparative picture of sustainable assessment methodologies, looking at the European Commission's Product Environmental Footprint (PEF) and the assessment method of CEN TC 350 standards, the Environmental Product Declaration (EPD). On 20th of February the final report of the Scenarios towards a resource efficient Europe study was presented at a workshop. Both the macroeconomic approach and the analysis of the technical improvements were discussed in deep by the participants. The event was closed by a panel of experts including Pavel Misiga from DG Environment who encouraged the participants to support the activities of his DG to promote resource efficiency, in particular in the construction sector.
