The European Commission is considering a review of the Ecodesign Directive in 2015. To prepare for this review, it launched a stakeholders' consultation in the last part of 2013 on both the Ecodesign and the Energy Labelling directives. The European Council decided last week, at working party level, not to object to this [delegated act](#). Following this, a formal Council decision will probably be adopted next week, which would allow the publication of the final document in the Official Journal of the European Union before March. After the official publication manufacturers will be able to make available their DoPs on websites instead of supplying it in paper form or by electronic means.

LIFE environmental funding needs design and implementation improvements, say EU Auditors

LIFE ([L'Instrument Financier pour l'Environnement](#)) is an additional financial instrument supporting environmental and nature conservation projects throughout the EU, which is managed directly by the Commission. The Court of Auditors carried out an audit and found that, overall, the LIFE 'Environment' component was not operating effectively because it was not sufficiently well designed and implemented. This month the first stakeholder consultation meetings for the PEF pilots will take place in Brussels. The groups will discuss the definition of the product group, the existing Product Category Rules and the "representative product". Mortgage Credit Directive adopted

On 28 January, the Council adopted a Directive aimed at creating a single market for mortgage credits, with a high degree of consumer protection. By ensuring that mortgage credit markets operate in a responsible manner, the text also seeks to promote financial stability. The Directive establishes conditions to ensure a high degree of professionalism amongst creditors and credit intermediaries. It sets out principles for marketing and advertising, and obligations for pre-contractual information, as well as requirements for information concerning credit intermediaries and for information on the borrowing rate. Member states have two years to transpose the Directive into their national laws, regulations and administrative provisions. For more information, click [here](#).

International Property Measurement Standards (IPMS) Consultation

The IPMS Coalition aims to harmonise national property measurement standards through the creation and adoption of agreed international standards for the measurement of office, residential, industrial and retail property. The IPMS Coalition invite your comments and feedback on their draft of International Property Measurement Standards for Offices. They will produce a final standard after they receive the consultation's feedback. The aim of the standard is to enable properties to be measured on a transparent basis that promotes market efficiency through greater confidence between investors, occupiers and funds.
