

As of 1st September, there will be a number of changes at the European Commission Directors-generals level.

In turn, Lowri Evans will lead DG GROW. Last but not least, Johannes Laitenberger will replace Alexander Italianer as head of DG Competition.

The objective of this initiative is to consult stakeholders on the review of the Energy Performance of Buildings Directive and evaluate whether the directive has met its aims. The consultation will also explore issues in relation to the Smart Finance for Smart Buildings initiative and the links of the directive with other energy policy areas. The public consultation launches the review of the directive, which is due by the end of 2016 as required under Article 19 of the directive. Read more...
