
## hEN and EAD lists in the OJEU updated

On 14th October the updated <u>list of EAD</u> was published in the Official Journal. Two weeks later the updated <u>list of harmonised standards</u> under the Construction Products Regulation was also published. In the table the references to EN 13383-1 (Armourstone), EN 14351-1 (Windows and doors) and EN 16034 (Pedestrian doorsets, industrial, commercial, garage doors and openable windows) include notes to explain additional rules to citation.

### Citation of harmonised standards



In addition to the meetings between CEN Technical Committees, CEN CENLEC Management Centre and the EC we are also working in action 5 of the Joint Initiative on Standardisation to find solutions to some of the reasons for blockage, in particular the introduction or revision of classes and thresholds but also other issues such as dangerous substances clauses or pass/fail criteria declaration.

### CEN/TC 350 Plenary meeting 2016

CEN/TC 350 experts will meet in Berlin next week to review the outcome of the working groups and the future of the standardisation system for the assessment of sustainability of construction works. The revised Mandate M/350 and its implications on the revision of EN 15804 and other standards will be the most important topic on the agenda

EC will harmonise hazard and safety information for use by Poison Centres. This will become an obligation for manufacturers of mixtures for consumers since 2020, for professional users since 2021 and for industrial users since 2024. Read more...
