Efficient public procurement

To strengthen the Single Market and as part of the continuous effort to stimulate investment in the EU, the European Commission has put forward an initiative to promote efficient procurement.

This initiative has four main strands: definition of priority areas for improvement; voluntary ex-ante assessment of large infrastructure projects; recommendation on professionalisation of public buyers and consultation on stimulating innovation through public procurement. <u>Read</u> more...

Action plan: citation of harmonised standards

The European Commission and CEN developed an action plan to reduce the stock of non-cited harmonised standards. The first step will focus on solving the blockage of a list of standards. Next year the system of New Approach Consultants will change to Harmonised Standards Consultants. In the mid term new IT tools will be implemented to facilitate the work. <u>Read more...</u>
