## EC Technical Platform CPR

The European Commission will host the second meeting of the CPR Technical platforms, focussing this time on "Simplification, including SME related provisions". The event will take place the 18th of January 2017. The inputs collected during the meeting will be taken into account for a potential revision of the CPR.

## EU-LCI values published in EC website

The website of the EU-LCI have been migrated and is now published as part of the website of DG Growth. For the moment the website contains the values agreed in 2015 but an updated version will be published soon. These values will be the basis for the delegated act under preparation to classify the declaration of the release of dangerous substances from construction products to indoor air. [Read more...](#)

## EC study on smoke toxicity

European Commission commissioned BRE, Ecorys and Vito to develop a study to assess the need to regulate toxicity of smoke generated by construction products in fire within the framework of regulation (EU) No 305/2011. The kick off meeting of the study took place last 9th of January. The work will be developed in the coming months and a validation workshop of the draft study is expected in May.
